OBSERVATIONS:

THE LEGAL REPRESENTATIVE OF THE MINOR, BY SIGNING THIS DOCUMENT, DECLARES AND ACCEPTS:

- When the person who signs this document is the father or mother of the minor, he confirms that the decision to grant this authorization has been taken jointly by both parents.
- That his personal data and those of the minor he legally represents are those listed in the heading of this authorization document, as well as that the statements contained therein are true and complete, and that he expressly acknowledges having the consent of the other parent, or, where applicable, of the corresponding legal representative of the minor to sign this authorization on the basis of what is provided for in it.
- That by signing this authorization document, he expressly authorizes the minor to access the DiR Clubs with an invitation or by paying a one-time ticket.
- That he knows, accepts and undertakes to respect, and to ensure that the minor he legally represents knows and respects the Registration, Access and Use Conditions established by Clubs DiR, as well as any other specific regulations of Clubs DiR - which acknowledges knowing and accepting - and especially the ban on the use of UVA machines by minors, in accordance with what is established in the applicable regulations, accepting that breaching them may lead to the expulsion of the minor as DiR client.
- That he knows and accepts, and will thus enforce it on the minor, that if he is aged between 10 and 11, he can only use, among all the facilities available at Clubs DiR, those corresponding to changing rooms, pool area, paddle and squash courts, solarium, social area and restaurant. The minor will have to use the clothing that corresponds to him or her at your expense, depending on whether he is a boy or a girl. Minors in this age group must use the facilities accompanied by an adult who is a DiR subscriber. Consequently, the signatory accepts and consents that the minor must access the facilities under the supervision of an adult who subscribes to the DiR and knows that the DiR Group does not have an obligation to monitor and supervise the minor.
- That he declares and assumes under his sole responsibility that the minor's physical and health conditions are suitable for performing physical and/or sports activities, that he is not taking any medication and/or that this does not have any contraindications for physical exercise, and releases the DiR Group and its staff from all responsibility for any damage, injury or harm that the minor may cause or that the minor may suffer during the use of the facilities and/or equipment made available to the DiR Clubs, when they do not derive from an action or omission enforceable by Clubs DiR.
- That in compliance with Organic Law 3/2018, of December 5, on the Protection of Personal Data (LOPD) and Law 34/2002, of July 11, on Society Services of the Information and Electronic Commerce (LSSI) informs you that the personal data of the representative(s) of the minor and of the minor provided in this document and/or those that may be provided on the basis of their access as a guest or occasional access, including those relating to aspects of health, habits and images, will be incorporated into files under the responsibility of the DiR Group company that manages the sports center to which you access (the identification data of which are at the end of this document) and will be treated with the purpose of enabling minors to access the DiR Clubs as a guest/occasional access, attend to any query, request or contract for any service or product that Grup DiR offers to users in its facilities, as well as to maintain a history of commercial and communications links. We also inform you that access to the DiR Clubs is carried out through biometric control and has a security system through video surveillance, so the minor's data will also be treated for these purposes. On the other hand, by signing this document, the representative of the minor in his own name and in that of the minor expressly authorizes the processing of the respective personal data for the following additional purposes: (i) carry out surveys, statistics and market analysis; (ii) create profiles to personalize and improve our services; (iii) promote or advertise the activities, products and services offered by the DiR Group companies at any given time. For these purposes, the legal representatives expressly authorize Grup DiR to call them and/or send them advertising or promotional communications by post, email, sms or any other equivalent means of electronic communication. Likewise, and for organizational and operational reasons, as the sports center accessed by the Minor belongs to the DiR Group, the signatory expressly authorizes the introduction of his data and that of the minor in a common tool owned by the DiR Group for the same related purposes.
